A. THE POLICY

1. Introduction

- The Group's primary business activity is in resort developments outside city/ urban centers with its principal development lands sited in Dickson Bay in Port Dickson, Negeri Sembilan and other development parcels in Kuantan, Pahang.
- The Group appreciates that as a conscientious and responsible corporate citizen, sustainability practices [encompassing Environmental, Economic and Social (EES) aspects] will not only enhance business opportunities and deliver success for our stakeholders which including, among others, our investors, customers, employees, advisors, financiers and other business partners, but will also contribute to broader-based future benefits in a sustainable manner for our community, especially on EES related issues.
- Sustainability is also becoming a strong focal point by the regulators for PLCs as seen from the requirements to include Sustainability Statements and Reports in the Annual Reports of PLCs.
- The purpose of this Sustainability Policy ("Policy") is to establish the objectives and strategies for Tanco and its subsidiaries ("Group") with regards to sustainability matters.

2. Objectives

4. Governance

- The Board of Directors ("Board") is the ultimate governing body of Tanco. Tanco's sustainability strategy and policy is driven by the Board with delegation of responsibility to the Audit & Risk Management Committee ("ARMC") and a Chief Sustainability Officer ("CSO") who is to be appointed by the ARMC from within the senior management officers of the Group to help formulate, improve, update, implement and oversee the sustainability Policy of the Group per its operations.
- The CSO is also to be supported by a Sustainability Working Group which will drive, track and monitor the progress and improvements of the Group's key sustainability matters re the Policy.
- Each Department Head of the Group are also responsible for the planning and implementation by ensuring each Department's operational activities and business decisions made are aligned to this Policy.

 Our sustainability mission and vision as a responsible corporate citizen is to ensure a due and proper standard of governance to promote responsible business practices, to manage environmental impacts, and to support the social needs of the communities in which we operate along the EES framework.
